

**RESOLUTION OF THE BOARD OF COMMISSIONERS  
OF SAN MIGUEL COUNTY, COLORADO,  
ADOPTION OF AN AMENDMENT TO RESOLUTION 2013-15 STANDARDS FOR  
THE ISSUANCE OF RETAIL MARIJUANA LICENSES WITHIN UNINCORPORATED  
SAN MIGUEL COUNTY, COLORADO**

**Resolution 2014-7**

**WHEREAS**, following a February 19, 2014 Public Hearing the Board of Commissioners (BOCC) of San Miguel County, Colorado adopted an amendment to the County Land Use Code (Resolution 2014-6) adding a new Section 5-29 Medical and Retail Marijuana Facilities that would allow an owner or lessee to apply for a marijuana cultivation/grow facility special use permit through a Two-step review process in the Wright's Mesa (WM), Wright's Mesa Rural Agricultural (WMRA) and the Forestry, Agriculture and Open (F) zone districts;

**WHEREAS**, at the February 19, 2014 Public Hearing the BOCC considered limiting the number of marijuana cultivation/grow facilities in the Wright's Mesa (WM) and Wright's Mesa Rural Agricultural (WMRA) zone districts after receiving public testimony at the BOCC Public Hearings held on this matter on February 13, 2014 and February 19, 2014;

**WHEREAS**, the Public Hearings were publicly noticed in the Norwood Post on January 29, 2014 and in the Telluride Daily Planet on January 31, 2014. The February 13, 2014 Public Hearing was held at the Norwood Community Center to provide an opportunity for public testimony and a second Public Hearing was held at the BOCC's February 19, 2014 meeting in Telluride;

**WHEREAS**, the Board of Commissioners of San Miguel County Colorado considered this amendment to BOCC Resolution 2013-15, along with relevant evidence and testimony from the public, at Public Hearings held on February 13, 2014 and February 19, 2014.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Commissioners hereby unanimously approves an amendment to Board of County Commissioner Resolution 2013-15 Section 4. Local License Restrictions, first paragraph, as follows (underline is new language):

**Section 4. Local License Restrictions**

The Local Licensing Authority shall not approve an Application for a Retail Marijuana Cultivation Facility unless the Applicant also holds a State and Local License for a Retail Marijuana Store, a Retail Marijuana Products Manufacturing Facility, a Medical Marijuana Center, or a Medical Marijuana Infused Products manufacturing Facility, located within San Miguel County, where in an unincorporated area or within the boundaries of a municipality.

San Miguel County shall restrict the number of licensed Retail Marijuana Cultivation Facility Licenses to a total of four in the Wright's Mesa (WM) Zone District and the Wright's Mesa Rural Agricultural (WMRA) Zone District combined.

The remaining provisions of Section 4. Local License Restrictions, are not amended and remain unchanged.

**BE IT FINALLY RESOLVED** that the Board of Commissioners will schedule a public review for this amended Section 4. Local License Restrictions regarding the number of licensed facilities within one year of approval of this Resolution.


